



## WAIVER OF LIABILITY & COVID-19 Safety Acknowledgment

### **DISCLAIMER CLAUSE**

The Board of Directors of Canadian Parents for French Alberta Branch (“CPF ALBERTA”) AND their agents, officials, officers, directors, employees, volunteers, contractors, servants or representatives (hereinafter refer to as “The Releasees) are not responsible for any death, injury, loss or damage of any kind suffered by any person while participating in this event and all related activities of this event, including injury, loss or damage which might be caused by the negligence of THE RELEASEES. This event includes transportation around Elkwater and Fort Walsh and other activities organized by the CPF Alberta.
